Mille Lacs Lumber Company card 3 enclosed an offer from D.M.Sabin for 180,000.00 feet very fine pine "in the so-called Mil Lac Reservation for \$3.50 per M. " Secombe wanted to buy at \$3.50 outside price and mentioned Michigan men and Stillwater firms coming into region, the latter thinking of buying timber an putting it into Snake River, though Rum River is its natural outlet. The Milaca mill burned to ground March 20-21, 1890; no insurance; rebuilt at once. Hammons resigned a/c letter of Sept. 26, 1890 as vice pres. and Director of Co. Most of correspondence at this time is addressed to W.A. Stephens Cutting of timber out from Milaca on Mike Drew Brook to be finished w. er of 1890-91. Drives are mentioned. Letterhead of Nov. 19,1890

shows picture of log landing, river and log train, and a forest ba ground. Oak was becoming scarce by Nov, ..., 1890. Sales of cutover lands of Co. had liquor-excluding clause and thus was hindering development of village of Milaca by Nov. 25, 1890. "Our Town is growing fast and is becoming unmanageable. They are calling for a Town organization, two School teachers etc.and of course the Coy. are the principal tax payers altho we own a small portion of the Bldgs. in the Town." By Dec.30,189 the office of the Co. had been transferred from Milaca to St. Paul, perhaps because bills were running unpaid for months. Most of correspondence in 1890-91 relates to long unpaid bill; Occasionally there are glimpses of what was going on in the woods, who owned the logging

camps, where they were located, the amount of the cut of each, etc., but one has to piece together a good many bits of scattered data of this sort to get a clear picture of logging. lumbering, milling, and marketing of the white pine, oak, and other hardwood timber of the company. 48 boxes, 21 vols, and 5 in small box 2 oversize pieces, one a map of Milaca, the other maps and plats.
