The first lease of fishing privileges to Hill is dated June 17, 1898 and was for the period Jany. 1, 1900 to Dec. 31, 1909 at a rental of \$3000 per year. There is a letter from Philadelphia from Philip Schuyler of May 29, 1898 showing that S., John L. Cadwalader, and Gov. E. Pollock had "had the fishing of the St. John's River for eight years, through Mr Pollock have been in negotiation for the last few months

for a renewal of our lease, expiring in 1900.Mr. Cadwallader then goes By a letter received from your Secretary... daded St. Paul, May 25, we learn for the first time, that you have leased the river from and including the fishing season of 1900." He then describes the river, the house erected by the lessors, the best fishing pools. There are maps and plats, data on fishing expeditions to the river, often on the "Wacouta," Hill's yacht, hames of companions on such trips scores kept of salmon taken by Hibl and others year by year through 1919, data on poaching by local residents, a flood in the autumn of 1906 that did great damage, plans and other data on the erection of several buildings, names of employes and their relations with Hill and his secretaries, who oversaw those relations, report Con Comd O

St. John River Papers--card 2----1897-1919 on nearby rivers, etc. The correspondence and papers in general in this part of the collection end with 1910; the rest are in the estate papers of J.J.Hill in the Louis W. Hill papers. The fishing scores, however, go on through 1919. Many letters received from others than employes and merchants in Canada relate to the slamon tha Hill and his guests sent to prominent persons in the U.S. and Canada, such as R. B. Angus, Lord Grey (who often was a guest on the river). Hill! New York friends and associates, other railroad men, prominent politicians like Grover Cleveland Chas. Steele, J.P. Morgan.
