# **BIOGRAPHY OF FRANK HOPKINS**

Frank Hopkins was born November 7, 1877 in rural Cairo Township, Renville County, to Charles H. and Susan Christman Hopkins, where he lived on the family farm until he was 17 years old. After graduating from the Fairfax public schools he taught school for a time but later continued his education at the Minnesota Normal and Business College (Minneapolis), graduating in 1899, and at the University of Minnesota, where he obtained a law degree in 1903.

Following his graduation from the University, Hopkins returned to Fairfax, where he practiced law for over 40 years, and was actively engaged in the political, civic, cultural, and religious affairs of the city and surrounding area. A Republican, he served two terms (1911, 1913) in the Minnesota House of Representatives and was an unsuccessful candidate for Congress in 1930. He directed the Citizens Band of Fairfax for approximately 35 years, having begun his association with the organization as a piccolo player at the age of 13. He was active in the Methodist Episcopal Church of Fairfax in a variety of capacities, including those of Sunday school teacher, choir director, and trustee.

Hopkins' interest in the history of Fort Ridgely and the Dakota Conflict of 1862 was undoubtedly instilled in him by his father, a Civil War veteran who was a leading spokesperson for the creation of a state park at the fort, a focal point of the Dakota Conflict; who served as park commissioner for many years; and who was a founder of the Fort Ridgely State Park and Historical Association, whose purpose was to promote the park's development and preserve its historical heritage. Hopkins' long association with the fort began during his childhood, when he played fife in the fife and drum corps. As an adult, he played a significant role in getting the state park established by the State Legislature during the 1911 session; staged historical pageants and presented lectures there on the history of the fort and the Dakota Conflict, about which he was considered an expert; and served as president of the Fort Ridgely State Park and Historical Association.

Hopkins' interest in historical pageants was stimulated when he was asked to create an elaborate pageant depicting pioneer life in the Minnesota River Valley and the Dakota Conflict that was presented at Fort Ridgely State Park in 1939. His appreciation of and respect for Native American culture was aroused while serving as attorney for the heirs of Little Crow, the Dakota chief. During the 1940s and 1950s he continued to research and write about historical topics and American Indian culture; staged pageants; lectured; and, adopting the persona of "Chief Minnesota," performed monodramas he had scripted on the history and culture of American Indians for schoolchildren and others.

Hopkins married Estella Johanna Schramm in 1905. They had three children – two daughters, Ora and Lois, and a son, Wayne. Hopkins died July 22, 1959 in Aitkin, Minnesota, where he lived following Estella Hopkins' death in 1945. He was buried in Fort Ridgely Cemetery in the state park.
