Abstract:	This case concerns objections to attorneys' fees charged to the charitable trust of Charles K. Blandin in the sale of the Blandin Paper Company.

HISTORY OF THE CASE

This case arose from objections of the Attorney General to fees sought by the Northwestern National Bank of Minneapolis and the law firm of Oppeinheimer, Wolff, and Donnelly from the charitable trust of the late Charles K. Blandin, founder of the Blandin Paper Company of Grand Rapids.

Attorneys of the law firm and officials of the bank were the trustees of the Charles K. Blandin Residuary Trust, which under the provisions of Blandin's will became operators of the Blandin Paper Company. During the 1970s, the trustees were forced to look for a buyer for the paper company due to changes in federal laws governing the operations of private foundations. The trustees received an initial offer of 32.5 million dollars, which at the time seemed impressive. However, they sought further advice from the investment firms of Salomon Brothers and Piper, Jaffray & Hopwood, and were later able to sell the company for 79 million dollars to British Columbia Forest Products Ltd. of Vancouver, B.C.

A Ramsey County court judge ruled that the trustees had overpaid Salomon Brothers by \$50,000 and Piper Jaffray by \$25,000 and that they would either have to recover the amounts or reimburse the trust. The fee requested by the Oppenheimer law firm was reduced by \$25,000, while Northwestern National Bank was determined to be entitled to the full \$275,000 it had charged.

SCOPE AND CONTENTS OF THE RECORDS

While this case may not be particularly noteworthy, testimony and other documentation provided sheds some light on the operations of the Blandin Paper Company, its sale in 1977, and the workings of the Blandin Foundation.

The files include correspondence, depositions and exhibits, attorney and research notes, financial records, and other materials related to and documenting the case.
