Carlson vetoed certain line items in the Proposed Post-Secondary Education Budget bill, causing four organizations of faculty members of the state university, community college, and technical college systems, and students attending college in the community college system, to file suit in August 1991 claiming injury if the vetoes were upheld. Their suit challenged the validity of the purported vetoes, asserting that the governor acted outside the bounds of his constitutional authority which was limited to a veto of "items of appropriation of money." The Minnesota Supreme Court ruled the three vetoes to be null and void and without legal effect on December 20, 1991. |
