North American Free Trade Agreement [NAFTA] compliance correspondence, 1993-1995. 2 folders.

Correspondence and related documents concerning Minnesota laws and programs that might conflict or be inconsistent with NAFTA. Much of the correspondence is with David McClung, legislative assistant in the governor's Washington, D.C., and the National Association of Attorneys General, which includes information on the perspective of several other states. Agricultural, mining, and financial services programs and laws are some of the areas discussed.

Canadian sugar beet investigation, 1995. 4 folders.

The Canadian government was investigating whether sugar refined from United States (particularly Minnesota) grown sugar beets (and those from several other countries) was being dumped into Canada in violation of the Special Import Measures Act. The Canadian Sugar Institute argued such imports were highly subsidized by the other countries and harmed the Canadian sugar beet industry. The amount of subsidy against the American beets was found to be insignificant and that case dropped but cases against other countries (mainly from the European Union) were continued. The files include correspondence, pleadings, and other records which document the condition of the state's sugar beet industry.
