SCOPE AND CONTENTS OF THE RECORDS

Records regarding the restoration, preservation, and maintenance of the Charles A. Lindbergh House located in the Charles A. Lindbergh State Park in Little Falls, Minnesota. The records include correspondence, primarily between Eva Lindbergh Christie, daughter of Charles A. Lindbergh, Sr., and U. W. Hella, Director of the Division of Parks and Recreation; newspaper clippings detailing the house's use as a museum of the Lindbergh family, particularly Charles A. Lindbergh Sr. and Charles A. Lindbergh Jr., and restoration of the family's 1916 Saxon automobile; inventories of the house's furnishings, including items originally owned by the family; floor plans; a bound pictorial record with 67 views of the house's interior and exterior; and photographs, mainly copies, of the family, the first residence which burned in 1905, farm animals in the 1910s and 1920s, the Saxon prior to restoration, and the present house. The materials document the roles of the Lindbergh family, the Parks and Recreation Division, and the Minnesota Historical Society in preserving this historic building.

Concerns the possible sale of a portrait of Charles A. Lindbergh, Jr.

Letter, September 26, 1955, Eva Lindbergh Christie, Red Lake Falls, Minnesota to Hella. Response, Hella to Christie, October 10, 1955. 2 items.

Discussing the restoration of the house and Christie's role in that restoration.

Inventory of Items Delivered to the Lindbergh Home in Lindbergh State Park by Arch Grahn and Russell Fridley on June 2, 1959 (All but items #1 and #11 were previously turned over to the Society [Minnesota Historical Society] by Charles A. Lindbergh, Jr.); Inventory of Lindbergh Furnishings, undated.

Further discussion of the furnishings of the house, particularly a painting of Lindbergh, Sr. that Christie finds "offensive."

Letter, August 23, 1968, Christie to Hella. Response, Hella to Christie, August 27, 1968. 2 items.

Christie has delivered some of Lindbergh, Sr.'s books and sketches to the house and was glad to see the painting was gone.

Newspaper article, "Ripley Unit Seeks Parts for Old Lindbergh Car," *St. Paul Dispatch* or *Pioneer Press*, [pre-1973].

Details work begun by Co. A of the 747 Maintenance Battalion, permanently stationed at Camp Ripley, to restore the 1916 Saxon originally owned by the Lindbergh family. The following 1973 article refers to the car as being restored and on display.
