SCOPE AND CONTENTS OF THE FILES

Two sets of files kept by Howard J. Costello, Assistant and/or Deputy Commissioner (1961-1990). The American Indian services files (1975-1980) include correspondence, reports, and background materials documenting the services provided to or requested by Native Americans serving sentences within the state's prison system. Arranged in reverse chronological order; specific topics covered include an American Indian Folklore Group, chemical dependency programs, the American Indian Religious Freedom Act, a departmental Native American Program Coordinator, various advisory committees, and a 1979 report on the Anishinabe Longhouse program from 1974 through 1977.

The Minnesota State Prison investigation files (June-December 1975) include correspondence, background documents, press clippings, and transcripts relating to legislative hearings into conditions and management of the prison at Stillwater.
