#### SCOPE AND CONTENTS OF THE RECORDS

In August 1992, Minnesota submitted an application to the Pew Charitable Trusts (The Trusts) to be part of their Children's Initiatives Program, which called for states and communities to adopt a new way of working with families, reshape service delivery systems, and shift from a crisis-oriented, fragmented, and inadequate approach to one of inclusion and effective supports for all children. The state was selected as one of five states to participate in Stage 2. Participants in Stage 2 received a \$100,000 grant to prepare detailed plans for implementing comprehensive reform based on their initial application.

The state received a \$1.5 million dollar implementation grant from The Trusts in April 1994 for the four partners of the Minnesota Children's Initiative: Becker, Cass, and St. Paul/Ramsey counties and the State of Minnesota. The Initiative's health component goals were development of a standard set of benefits under Minnesota's health-care reform program that would meet the needs of all families and children; development of improved health-care access strategies for families and children, with emphasis on high-risk, special-needs and low-income populations; and development of cost and outcomes data for services associated with the second listed goal.

These files appear to be those kept by the Human Services Department in its role as a member of the Minnesota Children's Initiative. Included are the 1992 application, 1993 agreement, minutes and agenda packets, annual reports to The Trusts, materials documenting the individual partner's activities, correspondence, work plans and proposals, and related materials regarding governance, planning, finance, and organization.
