#### **OVERVIEW OF THE RECORDS**

Department of Education, and annual agreements by local boards of education for approved programs for adult home economics education.

#### SCOPE AND CONTENTS OF THE RECORDS

Reports submitted by school districts, summary reports prepared by the Department of Education, and annual agreements by local boards of education for approved programs for adult home economics education. Information provided in some or all of the reports includes course title, dates, length, description, and registration fee; instructor name and salary; number of enrollees, classification by sex and attendance, and occupations; and budget and travel expenses. Most of the courses were part-time evening classes for adults and out-of-school youths.

The reports submitted by school districts (Education Department Code XI-C-8c) include the following information: city name, school name and district number, county; name of instructor and salary for the course; course title, opening and closing dates, length of course and number of sessions; number of enrollees by sex and average attendance; registration fee; occupational classification of enrollees; brief resume of the course; signature of superintendent of schools; signature of state supervisor recommending reimbursement and amount to be reimbursed from federal and state funds. Related correspondence is sometimes attached.

The summary reports (Education Department Code XXIX-C-13) contain: school name, subject of the course, total salary paid, salary reimbursed (federal and state funds), total travel, travel reimbursement (federal and state funds), and enrollment numbers by sex.

Information provided in the annual agreements (Education Department Code XI-C-8) includes: title of the course; opening and closing dates of the class; number of meetings and

length of each; supplementary services (such as consultation, clinics, or demonstrations) to be provided; name and salary of teacher and type of and expiration date of teaching certificate; itemized budget; type of travel arrangements for teacher; approval signatures, with additional comments or stipulations made by the Education Department; and sometimes course outlines.

Most of these classes were part-time evening classes for adults and out of school youths. However, three years (1941-1942, 1944-1945, and 1947-1948) contain reports from high school day classes in home economics. Reports for these day classes contain the weekly teaching schedule of the instructor as well as much of the same information as the other school reports.

Information on non-reimbursed classes, cancelled classes, and special programs also is provided.
