SCOPE AND CONTENTS OF THE RECORDS

Maps and timber surveys of Itasca State Park (1900) and Pillsbury State Forest (1902); 1903 report on the Northern and Cloquet lumber companies' timberlands; maps, lists of forest rangers, and expenses for patrol and fire prevention work; a fire prevention broadside (1906); expense memoranda for Forestry Board work and for other activities that C. C. Andrews was interested in; and other forestry and fire prevention miscellany.

RELATED MATERIALS

"Record of payments for tree planting," formerly cataloged as part of the records of the Forestry Board, was determined to have been created by the State Auditor. It is now cataloged among the State Auditor's records as "Tree bounty payment records."

		Consists primarily of diagrams of individual sections of land, with accompanying (often lengthy) descriptive notes, mainly on land, timber, and other vegetation (pp. 9-118, 157-233). Supplemented by an introduction and table of contents (p. 1-11); expense account (p. 12, 15-16); record of photographic exposures (p. 13-14); photographs, mainly of timber, all identified by topic and locale (p. 120-155); and a "record of proceedings" (apparently land purchases) (p. 234).
		No published version of this report has been located.
		Field notes, Itasca Reserve, 1875. 1 volume. Surveyor's notebook.
		Maps of fire warden districts, [undated]. 1 volume. Small printed maps from an unknown source, cut out and pasted into the volume alphabetically by county. Many contain handwritten annotations giving additional township names, rangers' names [?], and related data.
116.A.3.2	2	Survey of Pillsbury Forest, 1902. 1 volume. A volume containing a copy of the published <i>Pillsbury Forest:</i> <i>Report of Survey and Working Plan</i> , by T. L. Duncan (23 p.), followed by [Duncan's?] tract-by-tract handwritten notes on timber, soil types, terrain, and the like.
		[Memorandum and account book], 1909-1921. 1 volume. Itemizations of expenses under several categories: forest protection, Forestry Board, prosecutions, Forest Service, emergencies, Itasca State Park support, forest reserves, and rangers, as well as Minnesota Monument Commission (1915- 1921) and miscellany, apparently that C. C. Andrews was involved in.
