The records include annual reports (1986-2007), a history of gambling in Minnesota (2005), minutes and agenda packets (1984-2004), rules proceedings files (1984-1998), manuals (1990-2008), and published records and reports (1985-2008). Topics covered include bingo, licensing, illegal gambling, paddlewheels, pull-tabs, gambling managers, and the economic effect of a statewide smoking ban on charitable gambling. A complete run of the board's newsletter, Gaming News, is also included.
