SCOPE AND CONTENTS OF THE RECORDS

Major topics covered in the subject files include air and water pollution, hazardous/toxic substances, mercury contamination, pesticides/herbicides, polychlorinated biphenyls (PCBs), community health services, formaldehyde, lead-based paints, methemoglobinemia, mosquitoes, typhoid fever, budget, children's camps, emergency/disaster plans, Indian affairs, industrial camps, migrant labor, legislation, the Missouri and Red Rivers, plumbing, plastic pipes, power lines, rules/regulations, sanitarians, toxicology, and a St. Louis Park creosote problem.

The files also detail the division's relations with numerous state and federal agencies and private organizations, including the Association of Minnesota Counties, League of Minnesota Cities, Minnesota Atomic Development Problems Committee, Minnesota Medical Association, National Sanitation Foundation, Public Health Service, Environmental Protection Agency, Association of State and Territorial Health Officers, Koppers Company and the state's Planning Agency, Board of Health, and department of natural resources.

There are also files documenting relations with other divisions and sections of the Health Department, particularly those dealing with analytic services, environmental field services and health, health risk assessment, and hotels, resorts, and restaurants.

Also contained in the subject files are environmental sanitation activity reports (1948-1957), activity plans and annual reports (1974-1979), and sanitation division ledger (1916-1922).
