The later years (1966-1986) contain more detailed information on the society's investigative and promotional activities.

- Minutes, January 15, 1944 – June 3, 1969. 1 volume.
Mostly handwritten; a few are pasted-in printed copies. Includes minutes of the executive committee, board of directors, and annual meetings.
- Minutes, January 10, 1966 – March 1986. 12 folders.
Typed or photocopied minutes; some are ribbon copies. Many include meeting notices and related documents. There is some duplication between these minutes and those in the preceding volume. The duplicates were kept because they are slightly different than the handwritten versions.
- Meeting notices and correspondence, May 1931 – March 1941, 1944-1946, 1955. 1 folder.
