ADMINISTRATIVE HISTORY OF THE MINNESOTA RIVER VOCATIONAL COOPERATIVE CENTER

The Minnesota River Vocational Center provided for comprehensive vocational education within the geographical boundaries of its member districts. It was established in 1972 under the Joint Powers Agreement [Minn. Stat. 471.59], which provides for the joint exercise of powers of two or more government units.

Following the passage of legislation specifically authorizing cooperation by school districts to provide expanded vocational and other education [Laws 1974 c252], the Center was approved by the state Department of Education under Minn. Stat. 123.351 in April, 1975, and designated District No. 959.

The independent school districts involved were No. 716, Belle Plaine (1972-1976), No. 717, Jordan (1972-1978), No. 393, LeSueur (1972-1978), No. 394, Montgomery-Lonsdale (1972-1982), No. 721, New Prague (1972-1982), and No. 719, Prior Lake (1972-1978).

The Center dissolved on June 30, 1982.

Note: Vocational centers are assigned school district numbers but are not independent school districts—they are considered special school districts.
