## ADMINISTRATIVE HISTORY OF THE CONSORTIUM

The Minnesota Urban Comprehensive Employment and Training Consortium, commonly known as the Metropolitan Manpower Consortium, was composed of the City of Minneapolis and the counties of Anoka, Carver, Hennepin, Scott, and Washington. Its purpose was to provide job training and employment opportunities for economically disadvantaged, unemployed and underemployed persons in their respective jurisdictions in accordance with the authority granted by the Comprehensive Employment and Training Act of 1973 [P.L. 93-203].

#### SCOPE AND CONTENTS OF THE RECORDS

Agenda packets (1974-1977; missing June-Nov. 1975), including minutes, correspondence, and reports of the Executive Committee, Operations Subcommittee, and Planning and Development Subcommittee; audit reports (1974-1976); comprehensive manpower plans (FY1975-FY1976); and subject files (1974-1980). The latter cover financial closeout, incorporation, bylaws, personnel policies, and planning.
