ADMINISTRATIVE HISTORY OF THE NINE MILE CREEK WATERSHED DISTRICT

The district was established by order of the Minnesota Water Resources Board on June 23, 1959, pursuant to the Watershed Act [Laws 1955 c799 s1]. Its function is to protect and manage the water resources within the district, which is approximately 50 square miles in surface area and encompasses the land area tributary to Nine Mile Creek in southern Hennepin County. Portions of the cities of Hopkins, Bloomington, Edina, Richfield, Eden Prairie, and Minnetonka are located in the district.

The activities of the district are managed by the five member Board of Managers, who are appointed by the Hennepin County Board of Commissioners. Managers serve staggered three-year terms and must live within the legal boundaries of the district.

SCOPE AND CONTENTS OF THE RECORDS

Minutes, correspondence, annual reports, engineers' reports, project files, and miscellany documenting all aspects of the watershed's organization and administration.

The record set of minutes came from the district office; all other materials in this series were assembled and maintained by James A. Jones as district director and officer.
