SCOPE AND CONTENTS OF THE RECORDS

Reports, plans, studies, and associated data relating to comprehensive local government planning and zoning efforts by Minnesota cities, villages, counties, and school districts. Most, but by no means all, of these reports were prepared with grant funds received under Section 701 of the Federal Housing Act of 1954. Also present are proposed zoning, platting, and land subdivision ordinances and regulations; program and goals statements; maps, and related miscellany.

Most of these studies were prepared by private planning firms and financial consultants hired by the local jurisdictions. Especially prominent are reports completed or collected by Midwest Planning and Research, Inc. which maintained portions of them as part of their corporate library until its dissolution. Several components of a 1964 State Resources Study are also present.

ARRANGEMENT OF THE RECORDS

In four subseries, each alphabetical by name of county, community, or regional agency, and with overlapping date spans. A given local government may be found in more than one subseries.
