#### SCOPE AND CONTENTS

Materials relating to the Planning Agency's interaction with the Governor's Office under commissioners Tom Triplett (1983-1985), Lani Kawamura (1985-1991), and Linda Kohl (1991-1992). Included are correspondence drafted for the governor's signature; notes and comment files regarding relations with the governor's staff; speech materials, legislative updates, and briefing files submitted to the governor; and letters submitted to the Governor's Office and to other state agencies. Several major themes occur throughout the files, including education, economic development, the economic health of the state, income tax, and state planning in general.

The correspondence drafted for the governor's signature contains both letters received by the Governor's Office and forwarded to the Planning Agency for response, and reply letters drafted by the Planning Agency for the governor's signature.

The notes and comments files relate to the Planning Agency's interaction with the Governor's Office staff (assistants, aides, and speechwriters). They include correspondence, memos, and informational copies of letters, memos, reports, studies, newspaper clippings, and other materials for comment or action by the Governor's Office and/or the Planning Agency.
