SCOPE AND CONTENTS OF THE RECORDS

Subject files (1961-1976), law enforcement departmental inventories (1975-1976), and published records and reports (1970-2002). The subject files contain reports, correspondence, evaluations, and background materials and focus mainly on peace officer training and training programs, including a training academy study and files on operational training programs in the state. There is also information on the Governor's Crime Commission, International Association of Chiefs of Police, and National Association of Directors of Law Enforcement Training. Some materials predate the board's 1967 establishment.

The inventories contain records of a survey of Minnesota's local police and sheriff's departments; the published records and reports include newsletters and miscellaneous print and near-print items of or about the board.
