SCOPE AND CONTENTS OF THE RECORDS

Correspondence, reports, and related materials covering such topics as an adult re-entry program, Dining Hall restoration, budgets, employees, institution history, visitors from Estonia (1992-1993), a 1911 complaint against Superintendent F. A. Whittier, secure detention cottage, group therapy, and discipline.
