ADMINISTRATIVE HISTORY OF AIRFLIGHT PROPERTY TAXATION

Taxation of airflight property, which began in 1945, is governed by Minnesota Statutes 270.072-270.079, Taxation and Assessment of Flight Property. Section 270.072 s2 provides that "The flight property of all air carriers operating in Minnesota under a certificate of public convenience and necessity or under authorization from the United States Civil Aeronautics Board shall be assessed annually by the commissioner [of taxation]." Aircraft with a gross weight of less than 30,000 pounds and flown on an irregular schedule are excluded. "Every airline company engaged in air commerce" in Minnesota must file a report providing the commissioner with prescribed information to enable him to make that assessment.

Sections 270.073-270.076 prescribe how the market value of flight property is to be determined, procedures for notifying airlines of assessed valuations and taxes, and avenues for appeal of the tax levy. Proceeds of taxes levied under this statute are credited to the state airports fund, which supports the construction, maintenance, and operation of airports and other air navigation facilities (Minn. Stat. 270.077; 360.017).

SCOPE AND CONTENTS OF THE RECORDS

Airflight property tax computation records for commercial airlines operating in Minnesota. They include tax assessment worksheets, financial and equipment information, notices of valuation and tax, annual reports (both the airline companies' printed reports, and annual reports of property and operations submitted on Taxation Department forms), correspondence, clippings, documents in appeals to the Board of Tax Appeals for reduction of tax, and an occasional hearing transcript.

ARRANGEMENT OF THE RECORDS

Most of the files are either chronological by year or alphabetical by airline name; there are also a few topical subject files interspersed.
