SCOPE AND CONTENTS OF THE RECORDS

Administrative, background, and report files for several urban planning grants made to the commission by the federal Department of Housing and Urban Development (HUD) and Housing and Home Finance Agency (HHFA).

The principal grant documented here is Project P-20, The Joint Program, an inter-agency land-use transportation planning program for the Twin Cities Metropolitan Area, funded by a HUD grant. Files include applications, contracts, budget and work program, progress and final reports, consultant files (contracts, correspondence, and study reports), other background and issues reports and studies, files of several advisory and review committees, and general background. The files are rich in information on such topics as the demographic, economic, infrastructural, and social status of the metropolitan area; growth and development options and prospects; transportation status and plans; and land use, particularly as it concerns transportation planning and recreational open space.

There are similar, but much smaller, files for a few other federal grants for projects that addressed general metropolitan area planning and implementation of the commission's work program.
