OVERVIEW OF THE RECORDS

Agency: Minnesota. Governor (1999-2003 : Ventura).

Series Title: Resolution and chapter files.

Abstract: Documents directly relating to bills that were either signed or vetoed by the

governor.

SCOPE AND CONTENTS OF THE RECORDS

Each file generally begins with a letter from Governor Ventura to the Speaker of the House or the President of the Senate stating that he received the bill, signed or vetoed it, and passed it on to the Secretary of State, with a copy of the bill and related memoranda confirming its disposition.

The bulk of the file consists of Governor's Bill Review Sheets sent by the Minnesota Planning Office to each government agency that was to be affected by the proposed legislation. They are color-coded for specific offices: white, Planning Office and the Legislative Relations Office; green, Attorney General's Office and the Finance Department; yellow, other state departments and offices; blue, Government Relations Office; and orange, House and Senate Republican and DFL caucuses. Each review form contains the signature of an office or department official, as well as any comments the office may have had regarding the bill. While many forms are merely signed or contain short comments, it is not uncommon to find multiple pages of comments, bill summaries, or supporting evidence attached to a bill review sheet, especially when a bill was deemed controversial.

The forms were circulated to elicit responses from various offices as to why the proposed legislation would be beneficial or harmful, information later used by the Governor to decide whether to sign a bill into law or veto it. This opportunity for comment invited a certain freedom and individuals were not shy about criticizing or praising a bill. There are also comments from business organizations, non-profits, and even individuals.

Each file also contains a computer printout or a photocopy showing the primary authors of a bill, the bill number and title, the actions taken in the House and Senate, and the date on which each action took place.
