#### SCOPE AND CONTENTS OF THE RECORDS

Records of the Waste Management Board's Hazardous Waste Management Planning Council, Solid Waste Management Advisory [Planning] Council, Waste Education Roundtable, and various smaller task forces and committees dealing with household hazardous wastes, resource recovery, solid waste policy, and waste stabilization containment. The records include minutes, correspondence, agenda packets, reports, membership lists, and subject files.

The records also contain files concerning the Local Project Review Committees (LPRC). The LPRC were established in each location selected as a candidate site for a commercial disposal facility for hazardous waste [Minn. Stat. 115A.22]. The files include minutes, reports, correspondence, grant agreements, work programs, and related papers.
