## Legacy Amendment Funding Recommendations for Fiscal Year 2016-17



► **\$41 million of the Arts and Culture Heritage Fund be appropriated to statewide history programs for Fiscal Year 2016-2017.** Based on experience of demonstrated need from the first three biennia, we respectfully recommend that the Minnesota Legislature appropriate funds for history activities from the Arts and Cultural Heritage Fund, over the next biennium, as follows:

**\$16.5 million for history programs and projects that are of statewide significance and are a state responsibility.** These are programs primarily operated by the Minnesota Historical Society.

*Examples:* improved history education and original research programs; intergenerational learning projects; increased access to collections and historic sites through technology enhancements.

**\$16.5 million for history projects and capacity development enhancements.** These are programs accomplished by local, regional, and other historical organizations and museums and are distributed through a competitive grant program.

*Examples:* funding for historical organizations and museums to preserve collections; create educational interpretive programs; preserve historic, archaeological, and cultural resources.

**\$6.25 million for history programs and projects carried out through partnerships between organizations to encourage collaboration and improve capacity and expertise.** Organizations could include local or regional historical organizations, the Minnesota Historical Society, or other organizations interested in using historical resources.

*Examples:* economic development through history via the Main Street Program; oral history projects; organizational capacity building; language preservation projects.

**\$1 million for a statewide survey of historical and archaeological sites.** The survey will identify and preserve locations, structures, and artifacts of statewide historical, archaeological, and cultural significance.

**\$750,000 for Minnesota Digital Library efforts** to collect and preserve historical and cultural digital objects from over 160 libraries, museums, and cultural heritage organizations; available through Minnesota Reflections and the Digital Public Library of America websites.

► **The Historic Resources Advisory Committee (HRAC), a volunteer citizen body created in the 2009 ACHF legislation, should continue to provide its expertise for oversight of grant programs.** HRAC members spent nearly 500 hours in the last grant cycle reviewing grant applications and presentations. This excellent work should continue.

► **The Minnesota Historical Society should continue to serve as the state entity that administers these funds.**

- MNHS has a 166-year track record of operating public programs that serve the people of Minnesota.
- MNHS has a 46-year track record of managing competitive grant programs administered by a professional staff. Grants are approved by a citizen committee.

### Why does history matter?

History teaches critical-thinking skills, communications proficiency, and interdisciplinary learning for students of all ages, providing a crucial educational foundation.

History creates economic development opportunities. These include construction jobs in the historic preservation field as well as employment from educational and history program activities for both the public and private sectors, while helping to preserve our historic resources for future generations.

History is specifically included in language in the Minnesota Constitution within the Minnesota Legacy Amendment:

“...Funding may be spent only for arts, arts education, and arts access and **to preserve Minnesota’s history and cultural heritage.**” (emphasis added)

### The Legacy Amendment has reenergized the field of history in Minnesota.

Highlights of activities from the three biennial appropriations include:

#### Proactive citizen involvement

in designing history programs, particularly grant programs, through statewide town hall meetings, workshops, and citizen reviews of grant applications.

#### History programs and projects

that benefited 500,000+ students, 10,000+ teachers, and 1,500+ non-profit organizations that preserve our past.

#### Demand for funding for

history and cultural heritage funding outweighs available resources 3:1.<sup>1</sup>

#### Statewide grant coverage:

1,500+ grants to 625+ organizations in all 87 counties.

#### Economic benefit: ACHF dollars

made an economic impact of \$2 for each dollar invested.<sup>2</sup>

#### Measurable outcomes and

**professional standards** applied to all allocations, ensuring responsible stewardship and accountability in expenditures.
